**Emergency Fisheries (Great White Shark and Grey Nurse Shark) Declaration (No. 1) 2008****Short title**

1. This declaration may be cited as the Emergency Fisheries (great white shark and grey nurse shark) Declaration (No.1) 2008.

**Purpose of declaration**

2. This is an Emergency Fisheries Declaration to declare great white shark (*Carcharodon carcharias*) and grey nurse shark of the species *Odontaspis ferox* as regulated fish. These species of shark are regulated in the way stated in this declaration.

**Nature of emergency**

3. This declaration is required to protect the sustainability of great white sharks and grey nurse sharks of the species *Odontaspis ferox* in the wild.

**Waters to which declaration applies**

4. The declaration applies to all Queensland waters.

**What declaration prohibits**

5. Taking or possessing of great white shark (*Carcharodon carcharias*) and grey nurse shark of the species *Odontaspis ferox* by all persons in Queensland waters is prohibited. Persons who take, tag or dispose of these species under an agreement with the State (i.e. shark contractors) are exempt.

**Expiry**

6. In accordance with the provisions of section 46(7) of the *Fisheries Act 1994*, this declaration will expire two months after the gazettal date.
