Within an easy 3.5hour drive or 45-minute flight from Brisbane and 90-minute flight from Sydney, Hervey Bay is brimming with investment opportunities, with all levels of government collaborating to support the right investors to attract regional growth and investment.

Known widely as a tourism hotspot, being one of the best places in the world to see and experience humpback whales, and on the doorstep of World Heritage Listed K'gari (Fraser Island), Hervey Bay also proudly supports a range of traditional and emerging industries including health, education, marine, aviation, aquaculture, timber and manufacturing. Supporting mechanisms are in place for the development of Indigenous businesses, small business and start-ups.

Hervey Bay is an ideal place to raise families, with excellent access to a wide range of private and public schools, outdoor lifestyles and excellent sporting facilities. There is also a strong tertiary sector which is increasingly determined to work with industry and government to deliver evidence-based solutions to local issues. The University of the Sunshine Coast Fraser Coast campus continues to train the next generation of nurses, teachers, animal ecologists and businesspeople, with course options expected to increase with demand.

Hervey Bay's Medical Precinct offers high quality health care and services for all stages of life, along with many and varied allied health services and training opportunities for the sector. ## Key strengths and specialities of the region

With an idyllic climate and enviable lifestyle, Hervey Bay is one of the world's premier nature destinations. Tourism and residential populations are growing creating economic opportunities such as housing development to commercial and retail, health services and tourism.

Opportunities also exist for the region to be able to provide health care, education, digital connectivity and other community services that not only cut across the tyranny of distance but also attract and retain all cohorts of the future population. The region is well connected with good road, rail and air access. Industry development is supported with several types of NBN connections, including Fixed Wireless, HFC (Hybrid Fibre-Coaxial), FTTB (Fibre to the Basement), FTTP (Fibre to the Premises), and FTTN (Fibre to the Node).

There are also significant private opportunities to build on several existing strategic projects such as the Hervey Bay Airport, Urangan Boat Harbour, Hervey Bay Medical Precinct and tourism across the region.

The state will continue to support coordinated investment in freight, priority road, rail and port infrastructure and airline services in acknowledgement of the strategic importance of Hervey Bay to the regional economy, social and enviromental circumstances.

## Opportunities

Whether you are in the aviation, tourism, health or education sector, Hervey Bay has something to offer. While the region is internationally recognised as a place of beauty, the opportunities in those sectors, as well as many others, make Hervey Bay a great place to work, live and play.



#### **Hervey Bay Airport Precinct**

The aviation industry is a major contributor to the region's economy and offers significant investment opportunities now and into the future. With strong population growth, a robust tourism industry, a gentle climate, low terrain, and existing airport infrastructure, Hervey Bay is ideally suited to accommodate an expanding aviation industry.

A leading regional airport, the Hervey Bay Airport offers regular commercial flights to and from Brisbane, Sydney and Lady Elliott Island and frequent charter operations to nearby K'Gari (Fraser Island). The precinct incorporates a domestic terminal and industrial services, such as air transport, aircraft maintenance, aviation education and airport infrastructure.

The Hervey Bay Airport has been specifically designed to cater for the aviation industry with its own Airport Precinct offering flood-free industrial land with direct access to the existing runway and services. Freehold and lease options are available to support specialised aviation manufacturing and servicing, as well as airside supply chain projects. There are significant opportunities to develop aviation manufacturing and servicing clusters within the Hervey Bay aviation precinct.

The Fraser Coast Regional Council owns the airport and has developed the "Fraser Coast 2031 Aviation Strategy" specifically to support interested aviation businesses looking to establish or relocate to Hervey Bay.



#### Tourism

Located within easy driving distance and just a short flight from Brisbane and with its mild, temperate climate, Hervey Bay is a natural tourism paradise and popular tourist destination. Tourism is a well-established and rapidly growing industry and major economic driver for the region.

Well-known as a whale watching mecca and named as the world's first Whale Heritage Site, recognising its status as one of the best places in the world to see humpback whales up close, the region is also known as the gateway to World Heritage listed K'gari (Fraser Island). The region offers great depth of natural, historical and cultural tourism experiences in a pristine natural environment which includes 14 km of golden beaches.

Visitors are able to experience award winning restaurants, relaxed dining opportunities and whale watching adventures. Close to services and facilities and the rich cultural heritage experience of nearby Maryborough, visitors can enjoy a range of accommodation options from luxury stays and island getaways to caravan and camping options. As a package this makes Hervey Bay the perfect holiday destination year-round.

Tourism investment opportunities include high end hotel development, motel revitalisation, nature experiences, wellness tourism, accessible tourism and more.



## Hervey Bay health and medical precinct

Hervey Bay's health and medical sector provides not only essential medical services but is also a growing contributor towards locally driven growth and employment. The region is committed to growing the medical industry by creating a medical precinct to provide a range of specialised medical services, as well as tertiary education facilities that support the establishment and advancement of the medical profession.

The precinct will incorporate both the public and private hospitals, as well as areas for private health professionals, commercial and retail opportunities.



#### **Urangan Boat Harbour Precinct**

The Urangan Boat Harbour Precinct is an iconic destination with significant investment and growth potential. The area draws upon Hervey Bay's unique strengths and natural assets with a range of investment opportunities, including marina facilities, residential living, convention and resort facilities, boat servicing and other tourism and research related facilities and the Indigenous history and culture of the Butchulla people.

The Urangan Harbour Master Plan sets a 30-year vision to develop a working harbour with the necessary facilities, infrastructure and amenities (including retail and dining experiences) to support local industries. The site will host a variety of green spaces and outdoor events and provide the focal point for the whale watching fleet, boating enthusiasts and recreational fishers.



#### Education

Hervey Bay boasts an exceptional education system, with a wide range of public and private schools and excellent tertiary education providers. There are several schools and colleges that cater to broad-ranging educational needs, such as St James Lutheran College and Hervey Bay High School, as well as vocational education (including TAFE and private training providers). Of course, the University of the Sunshine Coast, Fraser Coast campus is a great centrepiece provider for the health, education and business sectors.
