RE: Caval Ridge Mine Change Request 10 – Flora and Fauna, Audit Report and Air Quality Review Condition Changes

I am writing on behalf of BM Alliance Coal Operations Pty Ltd (BMA) as manager and agent for the Central Queensland Coal Associates Joint Ventures.

BMA requests that the Coordinator-General accept this letter to be a written application pursuant to the requirements of sections 35C and 35 E of the *State Development and Public Works Organisation Act 1971* (SDPWOA).

In accordance with Part 4, Division 3A of the SDPWOA, BMA submits this Change Request to delete three sets of conditions imposed on the Caval Ridge Mine relating to imposed flora and fauna requirements (conditions 3(a) to 3(d)), imposed condition audit report requirements (conditions 4(a) to 4(f)), and imposed air quality review requirements (conditions 16(a) to 16(f)).

The relevant conditions are detailed in Attachment A.

The basis of the initiation of this Change Request has been the adoption of a new outcomes-focused conditioning approach as evidenced in the Coordinator-General reports for the following projects:

Deletion of these conditions will achieve alignment with the new outcome-focused conditioning approach being applied by the Coordinator-General to recent decisions and as a result will reduce the administrative burden associated with unnecessary audit reports and air quality reviews. BMA has organised two comprehensive condition audit exercises by approved independent auditors in accordance with conditions 4(a) to 4(f), with reports submitted on 19 December 2012 and 9 December 2013. These audits have demonstrated that there is minimal risk of any substantive non-compliance occurring that may cause any harm to the community or the environment.

It is also relevant that comprehensive impact mitigation, environmental protection and compliance requirements apply via the conditions associated with the Caval Ridge Mine environmental authority granted in accordance with the *Environment Protection Act 1994* (EP Act) and the Commonwealth approval under the *Environment Protection and Biodiversity Conservation Act 1996* (EPBC Act). As a consequence, BMA considers that the activities required by conditions 3(a) to 3(d), 4(a) to 4(f), and 16(a) to 16(f) do not add any additional environmental protection value given the compliance requirements of the EP Act and EPBC Act approvals.

It should be noted that an offset requirement exists and has been conditioned separately by the Commonwealth as part of the EPBC approval. The Commonwealth's requirement, which also addresses the State's interests, has been complied with by BMA. Furthermore, the removal of the offset condition would also be consistent with the intent of the recently released draft Environmental Offsets Bill 2014 which outlines that where the Commonwealth requires an offset the State will not require an offset for the same matter.

The proposed condition deletions will reduce the administrative burden on the Caval Ridge Mine whilst not reducing the level of environmental management or protection required for the.

Attachment B contains a table identifying:

- all of the current applicable imposed conditions, incorporating the changes approved via Change Requests 1 to 9;
- the status of condition response activities; and
- compliance status.

Given the straightforward nature of this request which seeks to align the Caval Ridge Mine approval with the outcome-focused conditioning approach being applied by the Coordinator-General, BMA requests that the fees normally payable for a Project Change process be waived in this case.

BMA looks forward to your consideration of the Change Request and welcomes the opportunity to consult with the Office of the Coordinator-General in relation to any issues that may arise during your assessment of this matter.
