Townsville Battery Manufacturer
(relates to Jobs and Regional Growth Fund)

- Election commitment of \$3.1 million for a feasibility study into a proposed \$2 billion lithium-ion battery factory in Townsville with the funds coming from Queensland's JARG Fund has been confirmed.
- Discussions continue between RED and Industry Partnerships with proponent to develop up the Assistance Agreement for JRGF assistance.
- Proposed to meet with the proponent week commencing 14 May to discuss drafted terms in the Assistance Agreement.
- AQIAF/JRGF Panel has noted progress to date.
- DG has been updated via the election commitments process.
- DSDMIP also recently advised that the Townsville City Council is seeking to have a public event and signing of a 'Heads of Agreement' between QG, Townsville City Council and the company in late May to take place in Boston USA. Unknown at this stage what the HoA will entail, awaiting further advice from DPC. NB, the agreement to be developed between QG and IM3 does not involve Townsville City Council.
