Nonetheless, the Government anticipates that the Queensland racing industry can achieve a financial position between these two extremes in the mid to long term, as long as appropriate structural and governance improvements continue to be identified and actioned.

As discussed at the meeting, the Palaszczuk Government has decided to provide Racing Queensland (RQ) with a \$20 million grant in 2018-19 to be applied towards two new racing facilities, as well as additional financial support to ensure that there is no negative impact on Queensland's racing industry from the Point of Consumption Tax (POCT).

The Government will also forgive \$17.8 million of debt owed to the State by RQ, putting RQ in a better financial position to address industry needs. This debt was incurred when the then-Board of RQ implemented a series of prize money and spending increases, far above revenue available at that time. The debt was incurred following the signing of a 30-year exclusive wagering agreement in 2014, during the time of the former Government.

By providing RQ with this assistance, the Palaszczuk Government has sought to relieve RQ of several significant financial burdens, in order to free up the organisation's financial capacity to address industry requests.

The quantum of the additional financial support to compensate RQ is commercial-in-confidence. However, we can advise that in 2018-19, the Government will be returning to the racing industry 100 per cent of the value of POCT revenue.

As well as returning the full value of POCT revenue to industry this financial year, a further \$34.4 million has been committed by the Queensland Government to support the industry through the Training Track Subsidy Scheme, the Queensland Racing Integrity Commission and the Country Racing Package.

The Palaszczuk Government has committed over \$188 million to the racing industry since 2015.

This Government has specifically chosen to invest over \$70 million in country racing, because of its important role in bringing communities together and strengthening towns and cities as tourist destinations. The four major participant groups involved in racing in Queensland are the Australian Trainers Assoc (Qld Branch), the Queensland Thoroughbred Breeders Association, The Queensland Jockeys Association and the Queensland Race-horse Owners Association. These four groups have formed an alliance to create a united voice at this most critical time for the future financial well-being of racing in Queensland.

As a group which will represent Queensland Trainers, Jockeys, Breeders and Owners we formally advise the Queensland Government of our total dissatisfaction with the lack of both financial and emotional interest in our industry, a concern that has been ongoing for many years but reached an all-time high with the recent announcements on the distribution of the Point of Consumption Tax.

Racing industry participants are in the majority battlers who work long and hard to put on the show that we all know as Thoroughbred Racing. During our Winter and Magic Millions carnivals and through smaller carnivals throughout the State, you the Government are always on hand to share in the focus and attention these events provide. But week in week out the participants keep the show on the road, keeping the communities involved in the social environment of racing, employing thousands of Queenslanders and contributing the local economies throughout the State.

With the advancement of racing in the Southern States leaving us far behind, with that we have been seeing the demise of our own industry. Currently the only positive reason we can offer to have a horse raced in Queensland compared to NSW or VIC is our weather. We understand that reality is we probably never will be as strong as the other states, but whilst we keep losing ground at such a rapid rate the snowball effect will take place and we could soon see our industry plummet to the lows like which are currently seen in Tasmania, South Australia and New Zealand.

We have taken the approach that discussion and negotiation is no longer viable, and that the only way we can make our point is unfortunately through industrial action which is being requested vocally by our participants. We have planned Saturday October 27<sup>th</sup> as the day to stand down all industry participants from the race meetings designated for Doomben, Gold Coast and Toowoomba. As a courtesy to the country people we will have them continue with their meetings but there will be some disruptions on these days to ensure our point is made.

We do remain hopeful that this planned industrial action, that will no doubt further negatively impact our fragile industry, will not be required. We will follow this with another stand-down day on Tuesday the 6<sup>th</sup> of November (Melbourne Cup Day) with further days to occur if a satisfactory outcome is not achieved.

The Government has the chance to avoid this planned industrial action by offering a satisfactory package to allow Racing Queensland to quickly bring a financial boost to the industry through much needed significant prize-money increases and also commit to further increases in the immediate future as the proceeds of the P.O.C tax are collected.

Upon recognition and addressing of our concerns we will consider our position further.

We want to give Racing Queensland clear air to reset its negotiations with Government, and by agreeing to postpone any proposed industrial action, we feel this provides the best atmosphere to obtain the most beneficial result to our financially challenged racing industry.

We feel more comfortable now that our Government better understands the current position of thoroughbred racing in Queensland, and the ever-widening gap to our competitor States; further evidenced by yesterday's announcements from Victoria and Western Australia.
