The QRU wants to knock the eastern stand down and replicate the new National Training Centre (western grandstand) on the site. The QRU gave me a tour of Ballymore yesterday, just 12 weeks away from completion. It's all coming together quite nicely on the western side (the National Rugby Training Centre) and is starting to take shape.

I thought I was looking at what would be the first refurbished Olympic venue to be completed, but I was wrong. I was told the eastern stand, which was cited as one of the reasons Ballymore was chosen as an Olympic venue, is no longer fit for use and cannot accommodate crowds.

In the QRU's discussions with Brisbane Roar about a potential move to the venue, it has been made clear that the stand is off-limits, so only the new stand, the hill and the eastern concourse (where it spells out "Ballymore" in the pic below) will be usable. Crowds will be limited to 8000, and will not be in the main upper section of the stand.



As a result, the refurbished stadium will not meet FIH Olympic hockey competition requirements for spectator capacity (see here).

The QRU says it has a couple of options — refurbishment, or rebuild — with the latter being the preferred option, given the size of the task is unknown (eg. there would need to be a thorough examination for concrete cancer, among other structural issues). The QRU wants to knock the eastern stand down and replicate the new National Training Centre (western grandstand) on the site. The NTC cost \$30m, so it would not be unreasonable, with increasing prices, that a new eastern side facility would cost even more.

- In a previous answer, the Deputy Premier said: "Queensland's home of rugby, Ballymore was selected to host the Hockey for Brisbane 2032 because it was an existing venue with planned upgrades and has been identified as meeting International Olympic Committee (IOC) Hockey competition event requirements." - Is the Deputy Premier concerned Ballymore could be a smaller-scale Gabba, when it comes to cost blowouts at Olympic venues?
- Has any contingency hockey venue been identified? If so, where?




