## Subject: Caval Ridge Mine - Local Buy

I am writing on behalf of BM Alliance Coal Operations Pty Ltd (BMA) as manager and agent for the Central Queensland Coal Associates Joint Ventures.

BMA requests that the Coordinator-General accept this letter to be a written application by BMA that is in accordance with the requirements of sections 35C and 35 E of the *State Development and Public Works Organisation Act* 1971 (SDPWOA).

In accordance with Part 4, Division 3A of the SDPWOA, BMA submits this Change Request to delete the condition imposed on the Caval Ridge Mine relating to BMA's Local Buy Program.

The relevant condition is as follows:

**11 (g)**: The proponent must implement the Local Buying Program and include details of the procurement pipeline of upcoming opportunities and regular reports (at least quarterly) of the program's outcomes, on its website.

It is noted that Section 35E of the SDPWOA requires that the application for Project Change must be written and describe the proposed change and its effects on the project. Section 35E of the SDPWOA also requires the application to state reasons for the proposed change and to include enough information about the proposed change to allow the Coordinator-General to make the evaluation.

In relation to the requirements of Section 35E, BMA has received verbal advice from officials from the Office of the Coordinator-General that the following and attached information is likely to be sufficient for the purposes of Section 35E in this case.

The basis of the initiation of this Change Request is set out in the attached correspondence between BHP Billiton and yourself on March 2013. This correspondence confirms that the reporting arrangements stipulated in the Queensland Resources Council (QRC) Resource and Energy Sector Code of Practice for Local Content (Code) are preferable to the reporting arrangements required by the current condition.

The key reasons for this preference and, as a result, the proposed deletion of this condition, is to achieve alignment with the Queensland Government's policy position on local content and reduce the administrative burden associated with unnecessary quarterly reporting on BMA's Local Buy Program.

The proposed condition deletion is designed to reduce administrative burden on the Caval Ridge project whilst not materially affecting any part of the implementation of the project.

The success of the BMA Local Buying Program continues to grow. Some key outcomes include:

- 240 local businesses registered under the Program and ready to do business with BMA operations;
- 300+ orders placed by BMA with registered businesses totalling over \$4.6 million.

As outlined in the attached letter of 8 March 2013, BMA proposes to continue the implementation of the BMA Local Buying Program, and to report annually on the Program, as it relates to the Caval Ridge Mine, through the reporting arrangements outlined in the Code. BMA does not propose to implement the balance of the Code for Caval Ridge given the advanced nature of the execution phase of the project.

Given the background to, and straightforward nature of, this Change Request, BMA requests that the fees normally payable for a Project Change process change be waived in this case.

Dear Mr Mackenzie

I am writing to you about the Coordinator-General's conditions imposed on the Bowen Basin Coal Growth Project Caval Ridge Mine (CRM) regarding the Local Buying Program (LBP).

I understand that the Queensland Government is working with the Queensland Resources Council (QRC) on their proposed Resources and Energy Sector Code of Practice for Local Content (Code). The proposed Code is voluntary and is aimed at helping companies engage local industry in the supply of goods and services. Companies who adopt the Code would complete a Code Industry Report that will inform QRC in completing the proposed annual Code Effectiveness Report.

As the CRM project is conditioned on the LBP, I am seeking in advance what your intentions are regarding the proposed Code, should that Code be adopted. For example, would your preference be to continue with the current conditioned arrangements for the CRM project or to adopt all, or part of, the new Code.

If you prefer to adopt all or part of the Code instead of the LBP, either I can initiate the change under Section 35M of the *State Development and Public Works Act 1971*, or you could make an application under section 35C for a project change to amend the LBP conditions in the CRM project.
