Description of the land to which the designation applies

The Ministerial designation applies to land located at 168 MacDonnell Road Eagle Heights.

The land is described as the Parish of Tamborine, County of Ward, Lot 5 on RP125392 and Lot 132 on W311708 as per drawing SP227569. The land is located within the Scenic Rim Regional Council local government area

Type of community infrastructure for which the land has been designated

The land has been designated for the Eagle Heights Recovery Service Centre. The community infrastructure is described in Schedule 5 of the *Integrated Planning Act 1997* as follows:

(h) hospitals and associated institutions.

The community purposes undertaken at the site will be provided through:

- · evidence based live-in treatment programs
- group and individual counselling and support for residents and visiting clients
- abstinence-based programs with intensive education, counselling, and spiritual support
- provision of holistic health care needs for residents
- administrative, storage and maintenance facilities as necessary to support the delivery of those purposes.

The designation is subject to the following conditions:

- A lease shall be granted to the operator of the community infrastructure.
- Development and works for the designated use will be undertaken within that part of the land described in the registered lease. The total area to be leased shall be no greater than 7.2 hectares as detailed by Lease A and Lease B on SP227569
- The designated use will operate in accordance with the registered lease.
- 4. Accommodation provided for participants of the program will have a capacity of 70 persons.
- 5. Works on site must include sufficient water and waste water infrastructure to meet the needs of residents.
- 6. Queensland Health will take action to put in place a covenant on the title of the Eagle Heights site to provide additional and maximum protection for the site from potential future development or sub-division

Transport Operations Marine Safety Act 1994 Transport Operations Marine Safety Regulation 2004

I, Captain John Richard Watkinson, General Manager, Maritime Safety Queensland, pursuant to section 18A of the *Transport Operations Marine Safety Act 1994*, exempt the owners and masters of the ships and the ships mentioned in schedule A from Sections 115 and 118 of the *Transport Operations (Marine Safety) Regulation 2004*, subject to the following conditions:

- Category F1 Fast craft shall be designed, constructed and maintained in class in accordance with the rules of a classification society as required under National Standard for Commercial Vessels Part C.
- The design waterline shall be clearly and permanently marked by the load line mark as described in the High Speed Craft Code, clause 2.9.
- The High Speed Craft Certificate shall be issued by the classification society and a copy carried onboard the ship as part of the records to be kept under section 134 of the *Transport Operations (Marine Safety)* Regulation 2004.
- Fast craft mentioned in the schedule shall carry the special service notation (fast) to their service category
