1. Impacted Properties

This appendix details the properties and interests traversed by the permanent and temporary footprints for the Calvert to Kagaru Project (the Project).

Project definitions of relevance to this appendix are as follows:

- ▶ Temporary disturbance footprint: The area that would be directly affected by construction works (also known as the construction footprint). It includes the location of Project infrastructure, the area that would be directly disturbed by the movement of construction plant and machinery, and the location of the storage areas/compounds sites etc., that would be used to construct that infrastructure.
- ▶ Permanent disturbance footprint: The land required to encompass permanent infrastructure components of the Project. This includes components including the rail corridor, access tracks, signalling infrastructure, and bridge maintenance infrastructure.

1.1 Methodology

In identifying and calculating the areas of the properties and interests traversed by the permanent and temporary disturbance footprints, geographic information system (GIS) calculations were undertaken utilising the spatial datasets detailed within Table 1.1.

Dataset name	Data type
Queensland Digital Cadastral Database (DCDB) (Queensland Government, 2019)	The DCDB contains the property boundaries and related property description of all land parcels in Queensland.
Queensland Land Use Mapping Program (QLMUP) (Queensland Government, 2019)	The QLUMP dataset is digital map of the most recent land use of Queensland. Land use is classified according to the Australian Land Use and Management Classification.

When identifying the predominant land use of the impacted properties as mapped by QLUMP, multiple land uses may be mapped within the one allotment. In such instances, the land use that takes up the majority of the land within the footprint has been included for the purposes of the impacted properties list.

1.2 Impacted properties

Between Calvert and Kagaru, the permanent disturbance footprint for the Project traverses 175 properties and 19 interests (i.e. easements, strata parcels, below the depth plans). The temporary disturbance footprint, which also covers the permanent disturbance footprint, traverses 190 properties and 19 interests. The extent of area associated with these properties within the permanent and temporary disturbance footprints, as well as tenure and existing land uses of these properties, are detailed in Table 1.2.
