

# The Queensland Charter for Local Content (Charter)

## Contract Special Condition Clause

This clause applies if specified in the Annexure.

The Contractor must, and must ensure its subcontractors, in carrying out the work under the Contract:

- (a) comply with the principles of the Queensland Charter for Local Content (Charter) and any requirements under the Contract in this regard;
- (b) comply with any Statement of Intent or equivalent local content statement under the Contract;
- (c) complete and submit a Queensland Charter for Local Content – Project Outcome Report (available from [www.dsd.qld.gov.au/local-content](http://www.dsd.qld.gov.au/local-content)) to the Principal at practical completion and at such other times as reasonably requested by the Principal, with a copy to [gclc@dsd.qld.gov.au](mailto:gclc@dsd.qld.gov.au).
